# **UK Participation in Horizon Europe**

UK government announces new financial safety net for successful Horizon Europe applicants as association delays continue.

Under the Trade and Cooperation Agreement terms were agreed for the UK to become an Associated Country for participation in Horizon Europe, and UK applicants have been able to join consortia and submit proposals since the launch of initial calls. (see: European Commission Q&A)

As the EU has yet to formalise UK association, a new scheme announced on 29<sup>th</sup> November will guarantee funding for successful UK applicants for Horizon Europe grant awards, regardless of the outcome of the UK's efforts to associate to Horizon Europe. The funding will be delivered through UK Research and Innovation, which will publish further details about eligibility, scope and how to apply in the coming weeks. # Calls: 'Food, Bioeconomy, Natural Resources, Agriculture & Environment'

The main collaborative funding for agri-food research and innovation is a cluster of seven calls (Cluster 6) under the area of Global Challenges. The work funded under the calls in Cluster 6 will contribute to the objectives of the <u>European Green Deal</u> such as the <u>Biodiversity Strategy to 2030</u>, the <u>Farm to Fork strategy</u>, as well as the <u>long-term vision for rural areas</u>, and the Sustainable Development Goals. A more detailed list of policy areas covered by this call and to which applicants will need to refer can be found on this page.

# **Missions**

The EU Missions are intended to develop solutions to some of our greatest challenges in a defined timescale (by 2030). Each mission will operate as a portfolio of actions – such as research projects, policy measures or even legislative initiatives - to achieve a measurable goal that could not be achieved through individual actions. Three of the five missions are most relevant to the agri-food area. These are:

- Adaptation to Climate Change
- Soil Deal for Europe
- Restore our Oceans and Waters



The first Horizon Europe work programme for **Missions was** published in June 2021. **It included** actions that lay the ground for the <u>implementation of Missions</u>. A full research and innovation agenda **is expected by** the end of this year, followed by specific work programmes and calls.

For the Soil mission two work programmes are in development:

- The 2021 Soil Mission Work Programme will be published in December (there will be an Infoday), with an expected deadline in March 2022. One of the recent updates has been about creating structures for engagement with regions.
- A 2022 Work Programme is expected in April/May, with more specific topics and research areas.

# Circular Bio-based Europe Joint Undertaking (CBE JU)

## 'Building a greener, safer and better Europe'

The Circular Bio-based Europe Joint Undertaking (CBE JU), a €2 billion partnership between the European Union and the Bio-based Industries Consortium (BIC), was launched on 30th November 2021.



It will build on the success of Bio-Based Industries JU to advance competitive circular bio-based industries in Europe and will take over its activities. The main goals of the new European partnership are:

- Accelerate the innovation process and development of bio-based innovative solutions
- Accelerate market deployment of the existing mature and innovative bio-based solutions
- Ensure a high level of environmental performance of bio-based industrial systems

Publication of the first CBE JU **Strategic Research and Innovation Agenda** (SRIA) is expected in 2022 Q1, setting out draft details of its first calls, which are expected in Q2-Q3, with closing dates for the calls before the end of 2022.

# Other Calls and Opportunities

### ERA-Net <u>ICRAD</u> Call: One Health Approach to Zoonoses Research and Innovation

The overall goal of this call is to support cross-cutting research and innovation to better understand zoonoses, focusing on the animal-human-environment interface and by developing novel vaccine and diagnostics technology platforms to improve animal health and by consequence animal welfare. Preproposals should address one of the following research areas

- Research area 1: Improved understanding of animal-human-environment interface
  - Pathogen (Re)-Emergence and Host Adaptation
  - Host/Pathogen Interactions
- Research area 2: Detection and Prevention
  - Vaccine Technology Platforms
  - Diagnostic Technology Platforms

The research funded through this call is to improve health of livestock, therefore, research that mainly focuses on the below are not in scope of the call and are excluded: improving human health; AMR; companion animals; climate/ecology/environment; food-borne pathogens; animal welfare.

ERA-Nets bring together national funding in calls that are coordinated at a European level. Two UK funders (DEFRA and UKRI) are participating in this call. Please contact the funder's contacts which can be found in the pre-announcement document.

# DIH4AI - AI on-demand platform for regional interoperable Digital Innovation Hubs Network

DIH4Al is looking for innovative SME-driven experiments on the Al domain with the participation of DIHs, both at Regional and Cross-Regional collaboration level. The DIHs will support the SMEs through the Service Pipeline methodology proposed in the DIH4Al Project, and, in particular, with the delivery of L-BEST services. The objective is to enlarge the Al DIH network to as many European Regions as possible, at the same time that those experiments achieve to develop and integrate new assets of Al technologies, thus, complementing and extending the Al on-demand catalogue of solutions. SMEs will also be allowed to take advantage of the platform and experiments developed in the Project and the Open APIs provided on top of them, towards enhancing the DIH4Al-compliant systems with additional functionalities and features.

This EIT Food call supports the translation and application of advanced research, innovation and transformative business ideas and practices which help solve major systemic barriers to impact as they arise in key Focus Areas within the food system. The call targets four primary Impact Goals for food system change which will lead to a long-term contribution to the United Nations Societal Development Goals (SDGs) and the priorities of the EU Green Deal:
