# **UK Participation in Horizon Europe**

The UK's association to the world-leading Horizon Europe and Copernicus programmes was officially signed today (Monday 4 December) in Brussels. The **UK will be an Associated Country to the Horizon Europe Programme from 01 January 2024**; full details <a href="https://example.com/here/brussels/bull/

All calls within the 2024 Horizon Europe Work Programmes and beyond will be funded by the UK's Association to Horizon Europe.







- UK will be listed as an 'Associated Country' with full rights equivalent to those of Member States for grant funding for the 4 years (2024-2027) remaining of the Horizon Europe programme.
- We will once again be a full beneficiary partner, signing the grant agreements with the Commission.
- Funding for successful projects will come directly from the European Commission.

The UK Government Horizon Europe guarantee remains active and has been extended to cover any remaining



Horizon Europe grant calls under the 2023 Work Programme. If you are successful in a proposal under the 2023 work programme, you will still have to apply for funding from the UK Guarantee even if the grant agreement signature and project commencement are after 01 January 2024.

MSCA Staff Exchanges enhancing the research and innovation potential of organisations through staff mobility. They stimulate innovation, transfer knowledge, and boost the careers of researchers working in academia or industry. Consortia may submit a proposal in any scientific or technical area.

 HORIZON-MSCA-2023-SE-01-01 MSCA Staff Exchanges 2023 (NB. 2023 Work Programme – funded under UK Guarantee)

Funds international, inter-sectoral and interdisciplinary research collaborations. Note staff salaries are not funded – this should be work you are already doing (not funded by European funding) – the grant will fund travel expenses during exchanges to further the objectives of the planned research collaboration.

# Forthcoming Calls

### Circular Bio-Based Europe Joint Undertaking (CBE JU)

In preparation for the 2024 call, the <u>CBE JU Stakeholder Forum 2023</u> 'What next for the European bio-based sector?' will take place in Brussels on the 6-7 December. The forum will focus on three questions that are crucial for the successful development of the circular bio-based sector across Europe:

- How to stimulate demand for circular bio-based solutions?
- How to facilitate access to finance to scale up circular bio-based production in Europe
- What R&I do we need to keep European leadership in the bio-based sector in the medium-long term?

In advance of the publication of the draft annual work programme check out the <u>CBE JU Strategic Research</u> and <u>Innovation Agenda</u> (SRIA), which sets out detail of areas to be funded (and pay attention to what has already been funded in calls in the last two years – see 'Apply for Funding' => 'Closed Calls for Proposals').



The Annual Work Programme is expected in Spring 2024. If it follows the pattern of precious years the call is likely to open in June with a deadline in September.

#### **Missions**

Updated work programmes with details of 2024 Calls are imminent for the <u>EU Missions</u>, including 'A Soil Deal for Europe' and 'Restore our Ocean and Waters by 2030'.

Calls may follow the pattern of last year (opening in January 2023; deadline in September). The missions Work Programme for 2023-2024 can be downloaded <a href="here">here</a> but note that as of 04 Dec 2023 this only shows details for the 2023 calls.

# **Other Funding Opportunities**

### **IPIAMR forthcoming research call on AMR interventions**

The Joint Programming Initiative on AntiMicrobial Resistance (JPIAMR) will launch a competition for funding for international collaborative research projects aiming to improve, compare and evaluate the effectiveness, cost effectiveness, and uptake of existing interventions against bacterial or fungal infections and/or to design new interventions against fungal infections. This involves 21 funding organisations from 19 countries **including funders from UK** and has an estimated total call budget of over 19 M€. It will fund:

• Interventions to counteract the emergence and spread of bacterial and fungal resistance and to improve treatments.



- Opens 10 January 2024 a live webinar for applicants is planned for 24th of January 2024 details will be updated on the call page.

## **Tenfold NetZero Challenge Accelerator Programme**

Digital Catapult and DAERA have launched a Tenfold NetZero Accelerator Programme pilot project in Northern Ireland. The aim of this is to begin development of an innovation ecosystem and to identify up to six challenges from organisations within sectors under DAERA's remit that would benefit from innovative digital solutions and take them to the proof of concept stage. **Further Details:** Link

## Forthcoming: EIT Food Public Engagement Proof of Concepts Call for Proposals

EIT Food is looking for innovative public engagement project ideas with the potential for societal impact, to be tested in a Proof of Concept (PoC) phase. A Proof of Concept is a scoping exercise to test whether an idea, a certain concept or approach when turned into reality, would bring societal impact as envisioned.

Via this call, EIT Food offers an opportunity for individual organisations or small consortia to spend sufficient time on testing and demonstrating the relevance of the proposed approach for establishing the societal impact feasibility of the idea.

Deadline: 15 August 2024, at 12.00 (CEST - Brussels time)

**Expected duration of participation**: Activities may last up to 6 months

## European Commission's Research and Innovation (R&I) Days 2024

The R&I Days 2024 will take place on **20 and 21 March 2024** both **physically in Brussels and online.** This annual flagship research and innovation event brings together policymakers, researchers, entrepreneurs,

and the public to discover successful EU-funded research and innovation projects and debate the importance of continued investment in research and innovation.

## Horizon Europe Strategic Plan 2025-2027 Analysis

The Horizon Europe Strategic Plan defined the main orientations for the research and innovation investments over the period **2021-2024** for the European Union. In 2024 we are now at the mid-way point for Horizon Europe and a gap analysis of what has been funded and what remains requiring investment and intervention underpins the development of the next Horizon Europe Strategic Plan.

This gives an insight into what might be in the forthcoming work programmes under each "Intervention Area". Here is a summary of the Commission's Gap Analysis for Cluster 6 areas in advance of development of WPs for 2025-2027. LINK: Draft Horizon Europe Strategic plan 2025-2027

For Cluster 6 we have been told there will be a single year work programme for 2025. The Commission will begin drafting it after adoption of the Strategic Plan 2025-2027 in Q1 of 2024, and we will expect publication



probably in September or early October 2024. This will be followed by a two-year work programme for 2026-2027.

## **European Networking Event "Successful R&I in Europe**



This is a very long running and successful networking and matchmaking event organised by the regional development office in North Rhine-Westphalia in Germany. Participants invited as speakers give a short presentation (ideas and/or results) with a focus on Horizon Europe calls, with the aim of finding future potential collaborators or becoming involved in established and new technology networks between researchers, entrepreneurs and multipliers related to Horizon Europe.

You can submit a pitch to become a speaker. If you are accepted the conference fee is waived and you get to present your idea and meet potential partners. The deadline for submitting proposals in the call for



presentations is **12 January 2024**. For others, seeking to meet speakers and other participants, a fee is charged. The registration deadline is **8 February 2024**.

<u>Successful R&I in Europe</u> 2024 will take place on 15-16 February at the Van der Valk Airport hotel, Düsseldorf, Germany.

## Future collaboration opportunities in energy and climate resilience and adaptation

As part of the <u>RIPEET project final event</u> in January 2024, ERRIN will host a *future collaboration opportunities* session, which will see the active participation of RIPEET pilot ecosystems and partners, and ERRIN Working Groups.

With the aim of further supporting its members in the development of successful project proposals related to stakeholders' engagement in the field of energy, climate resilience and adaptation and built environment, ERRIN has created a brief survey on upcoming calls. ERRIN members and their regional ecosystems are invited to express their interest by completing the online survey by 6 January 2024.

## The Northern Ireland Contact Point Network

The Northern Ireland Contact Point (NICP) network was set up in 2014 to support local applicants applying for European Horizon funding. Details are available on the <a href="network's website">network's website</a> which has been updated for Horizon Europe. Services offered by the NICPs include:

- ➤ **Guidance** on choosing relevant Horizon topics and types of action
- > Advice on administrative procedures and contractual issues
- > Training, assistance and advice on proposal writing, to improve the quality of proposals
- > Signpost to documentation (forms, guidelines, manuals etc.) and other supports available
- > Assistance in partner searches
